Programme Structure

Uttarakhand is one of the fastest growing states in India, thanks to the massive growth in capital investments arising from conducive industrial policy and generous tax benefits.

The state offers a wide range of benefits in terms of interest incentives, financial assistance, subsidies and concessions. To promote different sectors, the State Government brought a number of enabling policies such as MSME Policy 2015, Hill Policy 2008, Central Capital investment Subsidy Scheme, Mega Textile Park Policy, Mega Industrial and investment Policy etc. The Single Window Clearance System, as part of ease of doing business agenda, has been formed to provide necessary and time bound licences, permissions etc. for the establishment of industry in the State of Uttarakhand.

Proximity to key markets and supply centres of North India further adds to the attractiveness of the State as an investment destination primarily for FMCG sector. Other potential sectors for investment include Engineering and Allied Industries, Pharmaceuticals & Biotechnology, Electronics & ESDM, Hydel Power, Tourism, IT/ ITeS, Healthcare etc.
